The Coordinator networks with our referral agencies keeping our client numbers steady, at the same time supporting our volunteers and clients. Running several training sessions for new volunteers and ongoing training for all volunteers has been very successful this year. Our financial position has been maintained with thanks to the Boroondara Council and Boroondara Cares for their ongoing grants, the Rotary Clubs of Boroondara that have continued to support us financially, and fund raisers by the committee with support from Volunteers and family. This year we have seen our committee grow which enables the workload to be spread but also enables the organisation to grow with new eyes and new ideas. CO-ORDINATOR'S REPORT

(FROM PREMA SUBRAMANIAM)

The BFN had a total of 45 referrals from 1stJuly 2018 till 30thJune 2019.

The majority of referrals (38 cases) came from the Maternal and Child Health Services; 3 cases from Camcare, 1 case from a clinical psychologist, 2 self referred clients and 1 was to us by a BFN client.

REFERRALS IN 2019, (45 CASES)

- Clients assigned a volunteer, 22 nos
- Clients declined our services, 19 nos
- Clients unable to be contacted, 4 nos



REFERRALS:

- 33 clients out of the 45 referrals (73%) were paid a visit to be assessed. 8 clients were contacted by phone but declined our services and another 4 referrals could not be contacted.
- Out of the 33 clients visited, we matched 22 clients with a volunteer while the remaining 11 clients decided to do without our assistance.
- The 19 referrals that declined are made up of clients who decided they don't need The BFN, or they need more assistance than we are able to give and phone clients. (We had 10 phone clients.) Phone clients are mums who have had a visit from the coordinator, but for various reasons have not been paired with a volunteer immediately. While the coordinator stays in contact with the client to sort out the issues, the client decides they no longer require our help.

Besides the 45 cases mentioned above, we also had a further 20 existing clients. All of these 20 existing clients have ended with us sometime during this financial year.



The chart above are some statistics on what our clients are like. Most of our clients have no family support and are 1st time mums, and nearly a third of them suffers from anxiety or depression.

OUR VOLUNTEERS:

The BFN is proud of the commitment shown by our volunteers and thank them for their commitment to our service.

We have 22 active volunteers and another 13 registered volunteers who were either taking a break or on holiday.

When a volunteer has a client, the coordinator is in regular touch with them. We also keep in touch with our volunteers regularly via bulletins and newsletters, to inform them of upcoming trainings, information sessions and celebrations days being held by us or in the community.

We conducted 2 training programmes, one in August 2018 and another in May 2019. The volunteer training programme was held over 2 days and we recruited 12 new volunteers within this year. The training included sessions given by professionals from referring agencies i.e. a Maternal and Child Health Nurse and a worker from Camcare.

The opportunity for current volunteers to join a session and share their experiences with the new volunteers is also part of the training. We feel it is very important for our volunteers, who work alone in the community, to interact with each other so they know there is support and to share information.



FINANCIAL ACCOUNTS FOR THE YEAR ENDED 30/6/2019 TREASURER'S NOTES

On the income side Boroondara Family Network Inc. (BFN) enjoyed greater stability with the second year of the donations from Boroondara Cares Foundation (\$10,000) and the second year of the Triennial Grant from The City of Boroondara (\$8,678) support by what is probably the 20th annual donation from the Rotary Club of Glenferrie (\$5,000).

Income rose to \$29,115 which was just adequate and only reached that level because of a private donation of \$5,000.

Expenses jumped by over \$8,000 to \$27,836 and we would have suffered a deficit without the private donation. We cannot rely on that good fortune in future and must increase our effort to get more money from Rotary Clubs or through grants and fundraising.

There were two main reasons for the expenses increase. The first relates to events of the previous financial year when salary expenses dropped by about \$5,000 due to the illness of the (then) co-ordinator. During the absence of the co-ordinator, the role was run on a volunteer basis for about 3 months with a consequent reduction in salary.

This financial year, Prema, the new co-ordinator has worked the whole year with a resulting increase in salary expense (approx. \$6,000 more). Prema has proved to be a great asset to BFN.

The second reason is that this year is the first financial year that we have had an insurance expense for Public Liability and Personal Accident to cover our committee and volunteers. In the past we have been covered under a Rotary global policy, however this year the underwriter excluded us and other charities that do not have Rotary in their name. The policy cost \$2,253.00 this year and is going to be an ongoing annual expense.

We made a net surplus of \$1,279.31 which sounds good, but it needs to be appreciated that we cannot rely on continued good fortune of large private donations.

Assets on hand at year end were \$19,596 which is a good start for operating costs; however there are no reserves. There really needs to be a greater emphasis on fundraising to allow BFN to grow and succeed in the manner we all wish for.

The Treasurer would like to express his gratitude to President Dianne Sides and Secretary Wayne Worladge for their hard work and contribution during this year.
